

TERMS AND CONDITIONS
HERITAGE HUNTER LUCKY DRAW

Acceptance of Terms and Conditions

1. The Heritage Hunter Lucky Draw (the “**Lucky Draw**”) is organised by the National Heritage Board (the “**Organiser**”).
2. By entering the Lucky Draw, you confirm that you have read, understood and agree to be bound by these terms and conditions, including any amendments thereto (the “**T&Cs**”).
3. The Organiser reserves the right to amend the T&Cs from time to time, and modify, cancel or suspend the Lucky Draw at its sole discretion at any time. Notice of any such amendments, cancellations or suspensions will be posted on the website at roots.gov.sg.

Eligibility and Submission Criteria

4. The Lucky Draw is open to anyone residing in Singapore, except employees of the Organiser or the immediate family members of such employees.
5. There is no age restriction for eligibility. However, any winner who is under 18 years of age at the time of prize collection must be accompanied by a parent/guardian during collection or provide written consent of a parent/guardian in such form as may be required by the Organiser.
6. The Lucky Draw comprises the following three (3) weekly draws:-
 - (a) Week 1 Lucky Draw will be open for submissions from 0900 hours on Friday, 12 March 2021, to 2359 hours on Wednesday, 17 March 2021.
 - (b) Week 2 Lucky Draw will be open for submissions from 0900 hours on Friday, 19 March 2021, to 2359 hours on Wednesday, 24 March 2021.
 - (c) Week 3 Lucky Draw will be open for submissions from 0900 hours on Friday, 26 March 2021, to 2359 hours on Wednesday, 31 March 2021.
7. To submit a valid entry for the Lucky Draw, please complete the Heritage Hunter event on the website at roots.gov.sg, comprising 3 clues, which will bring you to a landing page with an entry form, and submit the entry form with all required fields completed accordingly. To submit a valid entry for the Lucky Draw, the entry form must be obtained and submitted within the respective Lucky Draw period, and all required fields in the entry form must be completed accordingly.

Selection of Winners and Prizes

8. All decisions by the Organiser relating to the Lucky Draw are final. The Organiser is not obliged to provide reasons concerning the selection of the Lucky Draw Winners or entertain any appeals whatsoever.
9. The Organiser will select up to one (1) grand prize and three (3) consolation prize winners for each weekly Lucky Draw set out in Clause 6 above, for the following prizes:-
 - (a) For the weekly grand prize: Tablet worth \$1,099 per winner

- (b) For the weekly consolation prizes: \$100 Capitaland Voucher per winner
10. Each Lucky Draw will take place on Thursday, 18 March 2021, 25 March 2021, and 1 April 2021 for Weeks 1 to 3 respectively, at 1500 hours, at National Heritage Board, 61 Stamford Road, #03-08 Stamford Court, Singapore 178892. Winners will be chosen at random, among entries received that fulfil the eligibility and submission criteria.
 11. All winners will be notified individually by email and mobile phone.
 12. If any winner cannot be contacted by the Organiser or does not respond to the notification by the Organiser within five (5) days, the Organiser reserves the right to select a replacement winner or forfeit the prize, and the originally selected winner shall not be entitled to any payment or compensation from the Organiser.
 13. The Organiser will also display the names of the confirmed winners on the National Heritage Board Facebook page.
 14. Winners will be further notified of the dates and address for collection of prizes by email. Winners will be required to provide such information as may be requested by the Organiser (including but not limited to full name and email address). The Organiser reserves the right to forfeit prizes not collected within thirty (30) days from the date of notification and the originally selected winner(s) shall not be entitled to any payment or compensation from the Organiser.
 15. Prizes are non-negotiable, non-transferable, non-refundable and cannot be exchanged for cash. Unless otherwise stated, the winner is solely responsible for any and all taxes and/or fees as well as all additional costs that may be incurred in relation to the acceptance of the prize.
 16. The Organiser makes no warranties, representations or guarantees either expressed or implied regarding any prize, including but not limited to any warranty of merchantability or fitness for a particular purpose.
 17. The Organiser reserves the right to disqualify any Lucky Draw winners, forfeit and/or reclaim any prize at any time if the Organiser deems that there has been a breach of the T&Cs by any winner, whether discovered during or after the Lucky Draw Period.
 18. The Organiser may in its sole and absolute discretion substitute, withdraw and/or cancel any prizes or make changes to the value and/or number of prizes at any time without prior notice. The Organiser is not obliged to provide reasons and shall not be liable for any payment or compensation to any person due to such changes.

Liability and Indemnity

19. To the fullest extent permissible under law, the Organiser shall not be liable for any loss, damage, liability, injury or costs and expenses relating to any person's participation in the Lucky Draw, including but not limited to any changes to the prizes, disqualification of entries, any winner's acceptance and use of his/her prize and any delay, cancellation, failure or omission on the Organiser's part to carry out the Lucky Draw whether due to force majeure events or otherwise.
20. You agree to indemnify the Organiser and hold the Organiser harmless from and against all liabilities, losses, damages, proceedings, suits, actions, claims and demands, costs (including legal costs on a full indemnity basis) and expenses whatsoever suffered or incurred by the Organiser relating to or arising from or in connection with any breach of the T&Cs by you.

21. The Lucky Draw is in no way sponsored, endorsed, administered by, or associated with, Facebook / Instagram, and you agree to release Facebook / Instagram from any claims. Questions, comments or feedback relating to the Lucky Draw are to be addressed to the Organiser only and not to Facebook / Instagram. You also acknowledge that by opening an account with and using the services, products or features of Facebook / Instagram, you are responsible for complying with the terms and conditions of these platforms and the Organiser shall not be liable in any way whatsoever for such account and usage.

Personal Information

22. You agree that the Organiser may collect, use and disclose your personal data as provided to the Organiser for (a) the purposes of administering the Lucky Draw and in relation to your participation in the same, including publicly disclosing your name should you be selected as a winner, (b) promotional, marketing and publicity purposes relating to the Lucky Draw and the Organiser generally, (c) for the Organiser's conduct of research, analysis and development activities (including data analytics, surveys and/or profiling) to enhance the Organiser's programme offerings and operations, and (d) for the Organiser's reference and archival purposes. If necessary, the Organiser may share this data with other Government agencies (or non-Government entities which have been authorised to carry out specific services by the Organiser) in order to serve you in the most efficient and effective way, unless such sharing is prohibited by legislation.
